- 1. TVG-Zimsen hf., ID No. 650269-4389, Korngarðar 2, 104 Reykjavík (hereinafter referred to as TVG-Zimsen), has an operating permit for customs clearance according to the Customs Act No. 88/2005, as amended (hereinafter referred to as the Customs Act), and provides the following services in connection with the customs clearance of goods: consultancy services in the preparation of customs declarations, requests for customs clearance of goods and payment of customs levies on behalf of importers.
- 2. With this power of attorney, the customer provides TVG-Zimsen with full and unlimited power of attorney to represent the customer with respect to the customs authorities in accordance with authorisations contained in the Customs Act, to sign binding guarantee declarations on customs declarations for goods that are cleared in the name of the customer according to this power of attorney and to request that the customer be debited for customs levies according to this power of attorney in accordance with the authorisations that the customer has for periods of grace to pay customs levies to the customs authorities.
- 3. The customer is to pay TVG-Zimsen a fee for the work and the services that the company provides to the customer on the basis of this power of attorney, in accordance with the effective price list of the company unless otherwise negotiated.
- 4. This power of attorney enters into effect on the date of its signing and shall remain effective for one year from that date. If not terminated before that time, the power of attorney is renewed automatically for a term of one year. The power of attorney may be terminated at any time by both parties with 30 days' notice. The termination shall be in writing and dispatched in a verifiable manner and shall enter into effect on the first day of the next month after the termination was sent.
- 5. The customs clearing terms and conditions of TVG-Zimsen, as in effect, shall apply to all work and all services that TVG-Zimsen undertakes for the customer in accordance with this power of attorney. The terms and conditions may be accessed on the website of the company www.tvg.is and can also be obtained at its offices. The customs clearing terms and conditions of TVG-Zimsen are included in this power of attorney and shall be an integral part thereof. By signing this power of attorney, the customer confirms that he has read these terms and conditions and approves their integration into the power of attorney.
